7.0 **POSITION OBJECTIVE:**

The School of Human Services and Social Work is seeking to appoint a convenor for field education courses within the Masters of Social Work (qualifying) program that is offered in distance mode via Open Universities Australia. While the position has a teaching focus, the Lecturer will also be required to undertake research and community service for the School. The position will contribute to the administration and promotion of the School and its programs.

8.0 **KEY ACCOUNTABILITIES:**

- 8.1 Develop, convene, teach and evaluate field placement courses for social work students in the Masters of Social Work (qualifying) program offered in distance mode.
- 8.2 Conduct research including submission of grant proposals and publication of scholarly work.
- 8.3 Contribute to School and University administration through participation on committees and marketing of School Programs.
- 8.4 Participate in professional associations and community activities of relevance to the School.
- 8.5 Participate in community engagement activities with industry partners and field supervisors.
- 8.6 Work collaboratively with academic and administrative staff in the School and the university.
- 8.7 Support compliance with relevant legislation and University policies and procedures, including equity and health & safety and exhibit good practice in relation to same.

9.0 **POSITION CONTEXT:**

- 11.5 Experience in a relevant human services field and strong links to the social work profession.
- 11.6 Effective communication and interpersonal skills and demonstrated ability to work in a collegial manner with staff, students and industry partners.
