Teaching baccalaureate level courses in digital media, including gaming, simulation architecture, design, and production, artificial effects, 3D characters, virtual environment design, 3D modeling and animation, and digital simulation concepts as well as software expertise related to this industry;
- 2. Duties and responsibilities associated with teaching the baccalaureate level courses include a minimum of 36 semester hours annually to include: preparing a syllabus for each course, instructing assigned classes, grading all quizzes, tests, and written assignments, and assigning final grades;
- 3. Staying current in emerging technologies related to the field;
- 4. Assisting students in completing their instructional programs by being actively involved in recruitment, retention, completion, internships, portfolio development, and placement;
- 5. Participating in College committees, presentations, and conferences including leadership positions.
- 6. Given the evolving nature of this field, this position requires the adoption of new versions of software as they appear in the market, and the frequent development of new courses for the changing curriculum in the Graphics and Digital Medial programs.
- 7. Continuing contact with industry through advisory committees, grant creation, and other research opportunities.

### ESSENTIAL PHYSICAL SKILLS:
