### Primary Purpose of the Position:

NCCC is has been established within AHSRI to support ongoing development and use of casemix classifications in health services research, evaluation and management.

The Research Fellow is a part time position within the AHSRI. The position participates in the NCCC program of work, with projects in the area of casemix classification development, evaluation of health services management using casemix analytics as a key tool, and the provision of services in relation to activity based funding and activity based management. The Research Fellow is supported by the Director, NCCC and is a member of a team including statisticians, casemix classification, and health service evaluation experts.

### Position Environment:

As the NCCC is a sub-centre of the AHSRI, staff are located at both the Wollongong and Sydney campuses of the University of Wollongong. The incumbent of this position will be based in Sydney, but will work from the Wollongong campus on a regular basis.
