### Primary purpose of the position:

The primary purpose of this position is provide dietary assessments and counselling and oversee the clinical trial component of the HealthTrack study, including trial implementation, data entry and participant communications.

## Position Environment:

IHMRI draws on the capacities of a number of research units with the University, including the Smart Foods Centre which delivering capacity in dietary trials. HealthTrack is an IHMRI funded research project, a component of which is an interdisciplinary lifestyle intervention trial. This position will be responsible for the conduct of that trial within the interdisciplinary team, including the development of participant communications, delivery of participant lifestyle counselling, collection of appropriate data, undertaking and supervising relevant data entry and providing assistance with data preparation.
